CALL TO ORDER

Chairman Claggett called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. Members of the Board present were Claggett, Kiner, Weitala & Bode. Absent Reider. Also, present was Deputy Auditor Wermers.

PLEDGE

Chairman Claggett opened the meeting with the Pledge of Allegiance.

APPROVE MINUTES

Motion by Kiner, second by Weitala to approve the minutes from the May 12, 2015 meeting. All members present voted aye. Motion carried.

SET DATE AND TIME FOR NEW MALT BEVERAGE AND WINE LICENSE HEARING

Motion Kiner, second by Weitala to set June 9, 2015 at 9:30 a.m. in the Davison County Commissioner's Room at the North Offices Building, 1420 North Main Street, for a public hearing to consider the applications of Doug Aslesen for a retail on-off Wine License and a retail on-off sale Malt Beverage License located on the South 375' of Lot 2, Except South 300' thereof in SE ¼ of 17T 103 N, R 60 W of the 5th P.M., Davison County South Dakota.
