CALL TO ORDER

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairperson Bode.

APPROVE MINUTES

Motion by Claggett, second by Weitala to approve the minutes from the November 29, 2016 meeting as amended. All members voted aye. Motion carried.

REPORTS

Commissioner Reider reported that he, Corrections Administrator Radel and Emergency Management Director Bathke attended a security presentation at Vantage Point. He said it was very interesting.

Commissioner Claggett reported that he attended the presentation by States Attorney Miskimins regarding Marcy's law.

Auditor Kiepke reported that checks from MTI for the County's share of crop production were received as follows - \$4,257.58 for yellow soybeans and \$4,309.98 for yellow corn.

PURCHASE CUTTING EDGES

At the request of Highway Superintendent Weinberg, motion by Weitala, second by Claggett to purchase 110 new surplus 3/4"x8"x8" cutting edges, curved for grader, 5/8" hole at a price of \$119.44 each for a total of \$13,138.40, which is a cost savings of approximately \$30 per cutting edge. ADOPT RESOLUTION TO DESIGNATE CAPITAL ACCUMULATIONS

Motion by Kiner, second by Reider to adopt a resolution to designate capital accumulation funds for the purpose of purchasing phone and/or mainframe and/or computer and/or security equipment. A roll call vote was taken as follows. Reider – aye, Weitala – aye, Claggett – aye, Kiner – aye, Bode – aye. Motion carried.

Resolution #121316-03 Resolution to Designate Capital Accumulations

Whereas, SDCL 7-21-51 states that a board of county commissioners may, by resolution, authorize the accumulation of funds for a period longer than one year for a capital outlay purpose which is otherwise authorized by law. For the purpose of this section, the term, capital outlay purpose, includes any purpose which is extraordinary in nature, exceeds the funding ability of a single-budget year, and may result in the purchase of services, materials, supplies, or equipment. The resolution is enacted if approved by a vote of sixty percent or more of the governing body and shall clearly set forth the purposes for which the funds are to be accumulated and the maximum amount that may be accumulated. The funds to be accumulated shall be expended within eighty-four months from the date of the resolution. If the specific purpose for which the funds are accumulated is no longer necessary, the funds shall revert to the fund from which the funds were originally appropriated. The amount of accumulation for a specific purpose may not exceed five million dollars. The accumulation of funds pursuant to this chapter is in addition to any accumulation of funds authorized by § 7-21-18.1; and

Whereas, Davison County wishes to continue to accumulate funds for the purpose of purchasing phone and/or mainframe and/or computer and/or security equipment; and

Whereas, \$57,880 remains in the capital accumulations fund which expires in February of 2017; and

Now, therefore be it resolved that \$57,880 will be the first installment in capital accumulations designated for the purpose of purchasing phone and/or mainframe and/or computer and/or security equipment for all County offices in the year 2017; and

Be it further resolved that an amount of \$20,000 per year for the years 2017 through 2023 be placed in Capital Accumulations. These funds shall be expended within eighty-four months from the date of the resolution. If the specific purpose for which the funds are accumulated is no longer necessary or the funds are not expended within the set time period, the funds shall revert to the fund from which the funds were originally appropriated.
