Dr. Marty Christensen, Commander of the Corn Palace City Post #2750 of VFW stated that the purpose and mission of the VFW is to service Veterans and the community. They sponsor various things such as youth baseball and various veterans events. The building is currently under construction. Every penny they take in goes back into the service organization to accomplish their mission. Bill Jackson, representing the Coacher-Goetsch Post No. 18 Bldg Corp said that all revenue from the Legion is going back into the building. They also sponsor various community events and programs such as softball, baseball and veterans at Christmastime.
