### **April 4, 2017**

#### **CALL TO ORDER**

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. Members of the Board present were Bode, Weitala, Kiner and Claggett. Absent Reider. Also present was Auditor Kiepke.

#### **PLEDGE**

The Pledge of Allegiance was led by Chairperson Bode.

### **APPROVE MINUTES**

Motion by Claggett, second by Weitala to approve the minutes from the March 14, 2017 meeting. All members present voted aye. Motion carried.

#### **PUBLIC INPUT**

Tim Pearson, who resides in Sanborn County, appeared before the Board to discuss an incident that happened on March 28, 2017. Mr. Pearson had been at POET and weighed his truck before he left. The weight slip provided to him by POET showed a total weight of 79,040 lbs. He said the road is posted as 55 mph, 8 ton per axle, maximum weight of 80,000 lbs.

Shortly after leaving POET headed east, he noticed two semis pulled over to the side of the road heading west. As he was heading east, he saw red lights behind him so he pulled over and was instructed by Troy Graves to pull to the side of the road a ways from the other two semis so as to try not to interfere with traffic flow.

Officer Daniel Fields asked him to come back to his vehicle. Highway Patrolman Brad Miller stated that some of his drive axles were heavier than others. Mr. Pearson did not feel he was illegal as his total weight was under the maximum 80,000 lbs. POET only has the capability of weighing the total, not individual axles. He said his truck was at a slant when DOT and HP weighed the axles so of course the ones on the lower end of the slant would be heavier and the ones on the high end of the slant would be lighter.

He was detained for an hour and fifteen minutes. He received a \$180 ticket for an overweight axle. He contends that when you weigh trucks on a slant, it isn't safe or accurate. He doesn't feel this is a win for anybody including POET, farmers and truckers.

Chairperson Bode thanked Mr. Pearson for telling his story.

# REVIEW BOARD OF EQUALIZATION AND OATHS

Director of Equalization Goetsch presented an overview of the responsibilities of both the consolidated Board of Equalization and the local Board of Equalization. Members of the Consolidated Board present were Commissioners Bode, Kiner, Weitala, Claggett, Mitchell School Board member Debra Olson and Mt. Vernon City Council member David W. Anderson.

It was determined that the County Board of Equalization will meet next Tuesday morning and possibly the following Tuesday morning. The Consolidated Board of Equalization will convene at 6:00 p.m. Tuesday, the 11<sup>th</sup> of April, Tuesday, the 18<sup>th</sup> of April and possibly Tuesday, the 25<sup>th</sup> of April.

DOE Goetsch said that her office has been using iPads, which has a sketching program. She said it is working out very well. Her office is also utilizing the APPTOTO app, which reminds taxpayers of appointments with her office. They also utilize change finder and have added a video to their web page detailing what assessors actually do.

### REGISTER OF DEEDS ANNUAL REPORT

Register of Deeds Young presented the 2016 Annual Report. Young explained that the M&P Fund was set up in 2013 to help all counties keep their records updated. Smaller counties do not always have the resources to do so. Of the \$5 designated for the M&P Fund, \$3 stays with the county and \$2 goes to the state to split among the 66 counties. This year each county received \$4,593.96. Davison County contributed \$8,820.00.

She reported that revenue from State funds, County funds and Transfer fees decreased.

There are several projects ongoing in the Register of Deeds office. Scanning back records continues, grantor/grantee up-dating is being done for eventual on-line access and conversions, indexing deed and miscellaneous records continues.

ROD Young is Vice-Chair of the ERecording Commission, which has been involved in writing rules, holding public hearings and reviewing rules. ERecording is not allowable in South Dakota.

At the request of Corrections Administrator Radel, motion by Kiner, second by Weitala to authorize Radel to solicit additional sick leave donations from employees that have not already donated to this employee, limited to eight hours per employee, for employee #7810. All members present voted aye. Motion carried.

Motion by Claggett, second by Reider to approve the February Auditor's account with the Treasurer in the amount of \$6,494,587.90. All members present voted aye. Motion carried.

## MEDICAL CONTRACT DISCUSSION

Corrections Administrator Radel presented a letter received from Mitchell Clinic, Ltd., the current County medical provider for the jail. The letter is asking for an increase in the contract amount from \$15,000 per year to \$27,500 per year, beginning May 1, 2017. Radel and Auditor Kiepke were asked to do some research as to the history of the contract. It will be discussed at a later date.
