PROTECTION ORDERS

Chairperson Bode asked States Attorney Miskimins to explain protection orders. He that a protection order deals with relationship issues. A protection order can be put into place if it is established there has been domestic violence or if it relates to stalking.

The order may be effective for several years. The terms of the orders vary greatly depending upon the circumstances. Young children may be a factor.
