## **April 17, 2018**

### **CALL TO ORDER**

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present. Also present was Auditor Kiepke.

#### **DISCUSSION**

Delmar Maeschen came in to clarify a few things. He said when he was here the first time, he did not refuse to pay the weed spraying bill for Rome Township. He said they were unhappy with the bill but didn't refuse to pay it. He stated the thistles were green and growing on June 21, 2017, when they were sprayed.

He also said there needs to be better communication at the Highway Department. He said there is a plugged culvert on 266<sup>th</sup> Street. He said he called the Highway shop last week, left a message, and has not heard back from Highway Superintendent Weinberg.

Mr. Maeschen would to see more detail on the weed bills. He would like to know what roads are sprayed when. Chairperson Bode explained that if the township is unhappy, they may hire privately. She doesn't feel expectations of 100% are fair to Weed Supervisor Geppert. He is basically a one-man show. She further stated that oftentimes problems develop in the fields then spread to the ditches. The county has no control over a private field.

Mr. Maeschen wanted to know what can be done if the township writes a letter to a landowner and the landowner takes no action. Bode said the County can do enforcements.

Discussion was held regarding the Tim Neugebauer project and the roads. Planning & Zoning Director Bathke and Deputy Jenniges said they would take a drive out to the area to look at them.
