April 3, 2018

CALL TO ORDER

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairperson Bode.

APPROVE MINUTES

Motion by Kiner, second by Claggett to approve the minutes from the March 27, 2018 meeting. All members voted aye. Motion carried.

ROME TOWNSHIP DISCUSSION

Delmar Mueller, Rome Township Board Member, appeared before the Board concerning last years' weed spraying on township roads. He explained that for years the township has hired the County to spray weeds. Last year, he was very unhappy with the job done. Mr. Mueller reported that weeds were sprayed June 21 and 22 of 2017. Thirty-five days later, there were weeds in the ditches. He is refusing to pay the bill the township received for \$1,003.20.

Mr. Mueller stated he keeps a log for every day of the year. He said that on June 21st it was windy and rained 35 hundredths of an inch.

When asked where the weeds were, Mr. Mueller stated they were on the north end between 405th and 409th Avenues. Mr. Mueller further stated that he and Don Garvis had been in conversation with Weed Supervisor Geppert.

Chairperson Bode reported we had been through a very dry period in July, then we received rain in August. It should have been spot sprayed in September. Bode believes we need to share the responsibility for the approximately seven miles that Mr. Mueller believes were inappropriately sprayed. She said she wished this would have been reported last year so something could have been done about it.

Bode will come up with a percentage and send a copy to the clerk of the township for payment.
