APPROVE REDACTION REQUEST

At the request of Register of Deeds Young, motion by Weitala, second by Reider to recognize the need for certain PII to be redacted from the public records and to approve a cost of between .0295 and .03 cents per page for a total of approximately \$16.815.00, as quoted by Extract Systems, with the costs coming out of the Modernization and Preservation Relief Fund. All members voted aye. Motion carried.

HEAR REQUEST FOR LAND

Michelle Carpenter, Executive Director of Dakota Counseling Institute and Janae Oetken, Clinical Supervisor of Stepping Stones appeared before the Board to discuss the land owned by the County that would square off the land owned by Dakota Counseling and occupied by Stepping Stones. Carpenter explained that in squaring off the land for their utilization, they would be able to enclose the area and offer more services for their clients. This would help immensely with anonymity of their clients.

The commissioners requested that Planning and Zoning Director Bathke and Deputy Director Jenniges take a look at the plan and have SPN or another engineering firm do a survey of the property. It will be decided once this is done how we proceed.

At the request of Deputy Kingsbury, motion by Kiner, second by Claggett to accept the resignation of Avis Tolsma effective May 11, 2018. All members voted aye. Motion carried.

JAIL DISCUSSION

Several topics were brought forward by Deputy Kingsbury concerning the jail. One issue is the fact that the new Reliance phone system won't "talk to" the Zuercher system or the commissary system. The jail has had to revert back to phone cards for inmates to make personal calls. A quote from Zuercher would remedy the problem for \$5,794 with a yearly maintenance fee of \$805. The commissioners were not ready to act on the problem until more research is done as to what was promised when the systems were installed.

The next issue presented was regarding the locks on the cells. They need to be replaced or rebuilt. The commission thought this was supposed to be part of the Security System managed by Vantage Point. Auditor Kiepke will research the minutes.

The next item was the Security Cell, which Kingsbury reported is in dire need of repairs. The commissioners want to have a team meeting with jail personnel and maintenance personnel to see what the next step will be.
