Motion to call to order at 6:49pm

Noah reviewed November minutes.

Treasurer's report from last month was \$6538.25. There were some bills paid and the Penguin Communications bill of approx. \$1000 will be due soon. There will be approx. \$4750 after all bills are paid.

Business:

- Mike passed around nominations for Member of the Year.
- Bill Sebert and Scott Houwman attended the United Way luncheon.
- Nathan reported the printer in the MEOC has been installed. Also the radios have been repositioned and the MEOC has been cleaned.
