Jessica Davidson appeared before the Board to report she felt Davison County had some personal property of hers that she wished to have back. Her full report may be found on file in the Davison County Auditor's office.

Wanda Kobes alleges the States Attorney has not filed paperwork against Mr. Jerke. She wants to know if at the very least his tank can be shut and capped. Mrs. Kobes said she doesn't feel commissioners are doing their job.

Commissioner Bode replied the commissioners would take her information and forward it on.

PROJECT UPDATES

Physical Plant Manager Ruml reported the following:

Dated this 10th day of December, 2019 at Mitchell, SD.

The new doors/key fob project at the courthouse is moving along. Some of the new doors have been installed and the key fobs will be worked on this week.

It was discovered the key fob system will need to utilize Windows 10. Right now, the heating and cooling system program utilizes Windows 7. However, that will need to be upgraded with a cost of approximately \$15,000. There will be more information to follow.

The project resulting from flood damage at the courthouse has come to a halt as the historical society needs to look at the building to determine the status of the building and what work can be done.

The gutters that were to be installed by Thanksgiving at the Fairgrounds have not been installed.

The new audio/video system at the Fairgrounds is up and running.

AMEND LEVY

At the request of Auditor Kiepke, as discretionary information was not available at the time of the adoption, motion by Kiner, second by Weitala to amend the levy for Davison County from 4.003 to 4.002. All members voted aye. Motion carried.

COMMISSIONER REIDER EXCUSED

APPROVE INTRODUCTORY WAGE INCREASE

At the request of Corrections Administrator Radel, motion by Kiner, second by Claggett to approve a wage increase of \$.50 for Tim Simmermon after successful completion of an introductory period effective November 30, 2019. All members present voted aye. Motion carried.

SIGN MINNEHAHA COUNTY AGREEMENT

Motion by Kiner, second by Weitala to sign the Minnehaha County Juvenile Detention Center agreement with a daily rate of \$236.90. All members present voted aye. Motion carried.

2019 JAIL BUDGET REVIEW

Corrections Administrator Radel reviewed reasons for the shortfall in the 2019 Jail budget. Some of which included an increase in medical needs, an increase of federal inmates, repairs, supplies, new staff, new uniforms, inmate phone cards and the jail cell lock system that wasn't completed in 2018.

Radel further reported the national average for staffing a jail used to be twenty inmates to one staff person. Now the average is five – ten inmates to one staff person, which is in line with how the Davison County jail is staffed.
