CALL TO ORDER

Vice-Chairperson Weitala called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. Members of the Board present were Weitala, Reider, Kiner and Claggett. Absent Bode. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Vice-Chairperson Weitala.

APPROVE MINUTES

Motion by Claggett, second by Kiner to approve the minutes from the January 14, 2020 meeting. All members present voted ave. Motion carried.

PUBLIC INPUT

Commissioner Reider reported that he attended the Rural Water conference in Pierre for 2 ½ days. He said the main topic of discussion was roads and bridges rather than rural water. He said Davison County has about as many bridges as any other county. Funding is going to be a big issue if we have flooding this Spring that washes any of them out.

SIGN AGREEMENT BETWEEN DAVISON COUNTY AND CIVIL DESIGN INC

As per the request of Highway Superintendent Weinberg, motion by Kiner, second by Claggett to sign the Engineer's Services Agreement with Civil Design Inc. for Structure Design, Bidding and Construction Administration for Structure #18-120-153 with a cost \$85,070. VSO ANNUAL REPORT

VSO Craig Bennett reported that he did 29% more interviews in 2019 then in 2018 and he completed 66 more claims. He feels the veterans helping veterans network is a big reason for the increase in claims.

There is a new program for Vietnam Veterans called Blue Water. He said he has about 12 claims pending. Bennett continues to do outreach in various ways.

Bennett emphasized that the Care in the Community program brings revenue to local communities. Although, there are still many challenges understanding the process and how to use it.

Bennett supports regionalization for VSO's. He would like to see Davison County as a "hub" for veterans.

The third day was spent at the White House. Kiepke described the experience as surreal. Attendees were invited to participate in several panel discussions held by President Trump's staff.
