CALL TO ORDER

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present telephonically, with the call in number and conference id noticed to the public. Also present was Auditor Kiepke.

Commissioner Claggett mention the ZOOM application and thought this might be an option for future meetings.

Chairperson Bode said that there is a list of roads that have had to be closed. She stated that Highway Superintendent Weinberg had been keeping Emergency Management Director Bathke abreast of the closings so that he may notify emergency personnel of alternate routes.

Bode further reported that some young adults completely destroyed a road in Mt. Vernon Township. She said that Mt. Vernon Township had reached out to her, but since it is a township road, they must repair it themselves.

Bode feels the courthouse procedures are working as well as can be hoped for. She said the various offices have made their forms available in the foyer.

Auditor Kiepke reported she listened to legislation during the day and into the evening yesterday. The main thing accomplished was rescheduling city and school elections to a later date if they aren't combined with the primary election.
