#### **CALL TO ORDER**

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. Auditor Kiepke took roll and all members of the Board were present telephonically, with the call-in number and conference id noticed to the public. Also present was Auditor Kiepke.

### **PLEDGE**

The Pledge of Allegiance was led by Chairperson Bode.

#### **APPROVE MINUTES**

Chairperson Bode reported she had gotten some updates from Highway Superintendent Weinberg. Weinberg told her his department has been working on reclaiming gravel in the southern end of the County. They have also been checking culverts. Water is receding which is allowing them to do things this year they were unable to do last year.

### **ELECTRONIC MONITORING**

States Attorney Miskimins said he was directed by the circuit court to explore possible alternatives to housing juveniles in JDC. There is a program that allows electronic monitoring of juveniles. He could get monitors through the Glory House in Sioux Falls for \$7.50 per day. This would be a significant cost savings as opposed to housing them. Some of these costs could also be recouped through grants.

### ART SCHLENKER PROPERTY

Art Schlenker was scheduled to appear regarding drainage on his property. However, he didn't call in so Chairperson Bode presented the following information. She said she has worked with Highway Superintendent Weinberg, Planning & Zoning Administrator Bathke and Deputy Jenniges regarding the property. Bode said it is a tricky situation because the County can't go on to personnel property. The drainage board also has no authority in the matter because it is personnel property.

Weinberg had said he could take about 8" of dirt out of the ditch, but the culvert would have to be moved. This process would cost about \$1,000 and it is unclear who would be responsible for the cost. Mr. Schlenker would like the ditch taken down about 3'. This would not be at all feasible.

Bode asked that Weinberg, Bathke and Jenniges continue to discuss the issue.
