PLEDGE

Chairperson Bode opened the meeting with the Pledge of Allegiance.

APPROVE MINUTES

Motion by Claggett, second by Kiner to approve the minutes from the December 22, 2020 meeting. All members voted aye. Motion carried.

APPROVE RESOLUTION FOR CONTINGENCY TRANSFERS

Motion by Weitala, second by Reider to approve the following resolution for contingency transfers for the 2020 budget year. A roll call vote was taken as follows. Weitala – aye, Kiner – aye, Claggett – aye, Reider – aye, Bode – aye. Motion carried.

Resolution #122920-01 Contingency Transfers

Whereas, SDCL 7-21-32.2 states that no expenditures shall be charged to the line item authorized for by SDCL 7-21-6.1, but such appropriated amount may be transferred, by resolution of the board, to any other appropriation in which insufficient amounts were provided or for items for which no appropriation was provided. When transfers are made from the contingency budget to other appropriations, whose revenue is provided by other than general fund revenues, a transfer of fund balances may be made from the county general fund to such other fund in the amount of the budget transfer.

Now, therefore, be it resolved that the following contingency transfers be made for the 2020 budget year: Transfer from the General Fund Contingency Budget 112 in the amount of \$72,976 to:

APPROVE DAVISON COUNTY EMPLOYEE WAGES FOR 2021

Treasurer Beintema asked the commission to consider giving the non-salaried employees a percent plus a quarter or \$.50 increase to keep competitive with other counties. He said it's not about losing staff, it's about retaining staff. Beintema ultimately recommended 2% plus \$.50.

ROD Young agreed with Beintema. She believes \$.50 is a slap in the face. She stated City of Mitchell is advertising for a library assistant with a starting wage of \$21.89 per hour. That is more than either of her employees make.

As per SDCL 6-1-10, motion by Reider, second by Weitala to approve and publish the following wages for fiscal year 2021, which include a \$.50 increase for employees making less than \$20.00 per hour and a 2.5% increase for employees making over \$20.00 per hour. A roll call vote was taken as follows. Weitala – aye, Kiner – nay, Reider – aye, Claggett – nay, Bode – aye. Motion carried.

The salary figures do not include longevity that may be due some employees. The salaries of Department Supervisors, Assistant State's Attorney and Corrections Administrator are prorated per the period worked throughout the fiscal year.

APPROVE RESOLUTION TO SET ELECTED OFFICIALS WAGES FOR 2021

Motion by Claggett, second by Kiner to adopt the following resolution, which approves a 2.5% for the elected official's wages for 2021, as all elected officials make more than \$20.00 per hour. A roll call voted was taken as follows: Kiner – aye, Reider – aye, Claggett – aye, Weitala - aye, Bode – aye. Motion carried.

Resolution #122920-02 Set Elected Officials Wages

WHEREAS, SDCL 7-7-9.1 states that the board of county commissioners shall establish, by resolution, the salary payable to the county treasurer, county auditor, and county register of deeds. The salary payable may not be less than \$35,952 based upon the salary schedule which is based upon the most recent decennial federal census of population for counties; and

WHEREAS, SDCL 7-7-12 states that the board of county commissioners shall establish, by resolution, the salary payable to the state's attorney. The salary payable may not be less than \$71,534 based upon the fact that the commissioners have designated the position of state's attorney as full time; and

WHEREAS, SDCL 7-12-15 states that the board of county commissioners shall establish, by resolution, the salary of the sheriff. The salary payable may not be less than \$46,110 based upon the salary schedule which is based upon the most recent decennial federal census of population for counties. The sheriff will also receive an additional 10% added to the \$46,110 for managing a full-time jail; and

WHEREAS, the Board of county commissioners may not decrease the salary of the county treasurer, county auditor, county register of deeds, county state's attorney or county sheriff during consecutive terms of office of the county treasurer, county auditor, county register of deeds, county state's attorney or county sheriff.

THEREFORE, BE IT RESOLVED, that elected official's salaries for 2021 shall be set as follows; auditor - \$65,883.47, treasurer - \$53,884.46, register of deeds - \$64,784.87, the state's attorney - \$95,546.10 and the sheriff - \$75,771.02. These salaries are not inclusive of longevity pay that may be due some of these officials.

ADOPT RESOLUTION TO SET COUNTY COMMISSIONER WAGES FOR 2021

Motion by Claggett second by Kiner to adopt the following resolution which approves a 2.5% wage increase for the Davison County Commissioners for 2021, with an extra \$2,400.00 paid to the chairperson. A roll call vote was taken as follows. Claggett - aye, Kiner – aye, Reider – nay, Weitala - aye, Bode - aye. Motion carried.

Resolution #122920-03 Set Commissioner Wages

WHEREAS, SDCL 7-7-3 states that the method of payment, whether per diem or salary, and the amount of per diem or salary shall be determined by the board of county commissioners in each county. If the per diem method is used, the county commissioners shall be allowed the per diem amount for each day they are actually and necessarily employed in the duties and business relating to county affairs and the duties of their office and in attending and returning from sessions of the board. The county commissioners shall be allowed mileage for the distance actually traveled in attending the meetings of the board, or when engaged in other official duties. The per diem shall be paid out of the general county fund. The per diem shall be set by the commission on the first regular meeting date in January of each year; and

WHEREAS, SDCL 7-7-5 states that the board of county commissioners may determine the salary of the commissioners. Such salary may be set by the board of county commissioners at its first regular meeting of each year. If the board of county commissioners fails to determine a salary, then the salary of a county commissioner in any one year is six thousand five hundred sixty-six dollars as per diem or salary in counties of fifteen thousand population and over and not more than thirty thousand population.

THEREFORE, BE IT RESOLVED that the Davison County Commissioners salaries will be set at \$18,560.00 for the year 2021, with the chairperson receiving \$2,400 more than the other four commissioners.
