  - a. The Davison County LEPC receives grant funds from the state, which are used to pay for air cards in the Search and Rescue vehicles.

- 6. Remediation/HAZMAT Issues
  - a. Initial 2021.007-CHS Spill
    - i. During the wind storm January 14, 2021 an empty AST was windblown into a full AST, releasing 27,500 gallons of 28-0-0. Most of the product was captured in the concrete containment, however some product impacted the surround gravel lot. The containment pit was pumped out and floor dry and excavation was done to the surround area. Davison County Search & Rescue provided scene lighting for the incident throughout the night. After the wind calmed down and it was safe, two damaged AST tanks were removed via crane.
