- 2. Approval of the amended Agenda.

- 4. Status:
 - a. The Davison County LEPC receives grant funds from the state, which are used to pay for air cards in the Search and Rescue vehicles.
 - i. Amount of 2021 grant: \$1,251.04
 - ii. Expended: \$942.56
 - iii. Remaining: \$308.48

- 6. Remediation/HAZMAT Issues
 - a. 7-19-21-Clark Paving-25 Gallons of hot joint compound on BNSF property. Compound has been removed, but BNSF has hired a consultant to be sure the cleanup was performed to their safety standards.
 - b. 9-6-21-Tire Fire at Graham Goodyear. DANR has contacted them and instructed them to properly dispose of the tires and contaminated soil by October 8, 2021.

- 8. Current Road Closures
 - a. James River Bridge at the Davison/Hanson County line on Shannard Road is 3 Ton limit effective today.
 - b. 394th Avenue between 248th and 249th Street-started now.
 - c. 397th Avenue between 258th and 259th Street-Replacement culvert to be completed November 1st.
 - d. 267th Street between 410th and 411th Avenue-water over road, vehicles can drive through. The road will be repaired soon when it dries up.
 - e. State-HW 42-Jim River Bridge Replacement East of Ethan in Hutchinson County-Bridge will be closed during construction.
- 9. Upcoming Road Closures:
 - a. 2021 County-Rehab a bridge just north of the Gary Busmuss farm, between 249th and 250th. (delayed)
 - b. 2021 State-HW 44-Parkston West-Shoulder widening project-Traffic will be maintained using flaggers.

- c. 2024 State-HW 37 from Main Street to airport road reconstruction-Traffic will be maintained to allow both directions.
- d. 2024 State-HW 38 Alexandria Intersection to Spencer Quarry-Shoulder Widening/grading project-Traffic will have flaggers.

- f. Future-City-Canal Bridge-Rusty will coordinate with the city when the canal bridge is closed to ensure other emergency routes are not closed at the same time.
