- 2. Approval of the amended Agenda.

- 4. Status:
 - a. The Davison County LEPC receives grant funds from the state, which are used to pay for air cards in the Search and Rescue vehicles.
 - i. Amount of 2021 grant: \$1,251.04
 - ii. Expended: \$1,060.40
 - iii. Remaining: \$190.64
 - iv. The new grant application has been received. Jeff will complete and get to Marius to sign.

- 6. Remediation/HAZMAT Issues
 - a. 9-25-21-POET-Urea delivery, upon delivery the hose on the truck broke and approximately 60 gallons of Urea spilled onto the concrete. Floor dry was applied, and the contents were disposed of. No stormwater was impacted.
 - b. 10-6-21-Case #2021.089-Edinger-Closure Report-165 gallons of roundup spilled in gravel yard, which was excavated and taken to the Pukwana Landfill. Soil samples sent to DANR lab and case closed.
 - c. 10-12-21-CHS Closure Report from June-84 gallons spilled, excavated, and taken to landfill.
 - d. Shortly after the meeting, an email was received from DANR that Graham Good Year had not returned any of the required paperwork and proof of clean up from the recent fire.
