CALL TO ORDER

Auditor Kiepke called the regular meeting of the Davison County Drainage Board to order at 7:00 p.m. Auditor Kiepke took roll call as follows: Members of the Board present were Jay Larson, Chet Edinger, Jerry Buchholz, Gregg Bult, Mark Klumb, Commissioners Bode and Kiner. Ex-Officio members present were Director Bathke, Deputy Jenniges and Auditor Kiepke. Absent Highway Superintendent Weinberg.

Guests – John Millan, a representative of JB Tile and Dave Estabrook.

OATH OF OFFICE

Auditor Kiepke administered the oath of office to all Drainage Board members.

ELECT CHAIRPERSON

Auditor Kiepke called for nominations for a chairperson. Motion by Buchholz, second by Edinger to nominate Jay Larson as chairman. Auditor Kiepke called for other nominations. Hearing none, motion by Bode, second by Klumb that nominations cease and a unanimous ballot be cast for Larson. All members voted aye. Motion carried.

ELECT VICE-CHAIRPERSON

Auditor Kiepke called for nominations for a vice-chairperson. Motion by Kiner, second by Buchholz to nominate Chet Edinger as vice-chairman. Auditor Kiepke called for other nominations. Hearing none, motion by Larson, second by Klumb that nominations cease and a unanimous ballot be cast for Edinger. All members voted aye. Motion carried.

APPROVE MILLAN FARMS PARTNERSHIP DRAINAGE REQUEST

Motion by Buchholz, second by Edinger to approve a drainage permit for Millan Farms Partnership, to drain from the SE ¼ Ex the SE ¼ of Section 1, T103N, R61W, Beulah Twp, Davison County and the

NE ¼ Ex the W 25 rods of the N 35 rods of Section 1, T103N, R61W, Beulah Twp, Davison County which will drain into the ditch on the SE ¼ of Section 11, Beulah Twp, Davison County, go under the road via an existing culvert into the NE ¼ of Section 12 and drain east 2.5 miles into Lake Mitchell.

Shannon Larson is fixing a county drainage ditch and re-establishing the bank of an open ditch. The property is legally described as the SE ¼ of Section 2, T 102 N, R 62 W of the 5th P.M., Davison County, SD.

Wayne Gronseth drains directly into a 3 dot blue line ahtat drains into Enemy Creek. The property is legally described as the NW ¼ of Section 28, T 101 N, R 60 w of the 5th P.M. and the NE ¼ of Section 12, T 101 N, R 62 W of the 5th P.M., Davison County, SD.





APPROVE AGENDA

Motion by Buchholz, second by Kiner to approve the agenda for the November 21, 2017 meeting. All members present voted aye. Motion carried.

APPROVE MINUTES

Motion by Klumb, second by Bult to approve the minutes of the August 15, 2017 meeting. All members present voted aye. Motion carried.

APPROVE DAVE AND SCOTT ESTABROOK DRAINAGE REQUEST

Motion by Bult, second by Kiner to approve a drainage permit for Dave and Scott Estabrook, with the condition that John Cristopher gives written permission to cross his land and 244th St. needs to be tamped in layers in 1' (ft) increments, to drain from the SE ¼ Ex the SW ¼ Ex the S729' (ft) of the W 1.328' (ft) of Section 2, T104N, R62W, Blendon Twp, Davison County. The project will connect to a solid 12" pipe, traveling north across John Cristopher's land, under 244th St., and into Sanborn County. The pipe will then dump into the un-named creek, which dumps into a Sanborn County Coordinated Ditch and then into Dry Run Creek.

Drainage Administrator Bathke reported there is one item pending that is in the process of administrative approval for Roland Johnson in Section 24, T 104 N, R 62 W of the 5th P.M., Davison County, SD.

ADMINISTRATIVE APPROVALS

Drainage Administrator Bathke reported the following as having gained administrative approval.

Klumb Family Farms drains into a blue line and only needed written permission from Dale Miller, which was obtained. The property is legally described as the SE ¼ of Section 9, T 101 N, R 61 W of the 5th P.M., Davison County, SD.

Doug Schley is draining east side of shed to dump into his trees to the northwest and is less watershed than the acre amount required for board approval. The property is legally described as Lot A-1 in the SW ¼ of Section 26, T 102 N, R 60 W of the 5th P.M., Davison County, SD.
