Dear Mr. Mueller:

The Department of Environment and Natural Resources is contacting you regarding the noted event. The department has recorded information provided about this event on an initial spill report form (enclosed for your review). The procedures for assessment and cleanup of spills such as this were developed to prevent pollution of the state's water resources. It is understood the oil spill has been contained to the shop area. In this situation:

- Spilled oil and impacted substances (soil, snow, ice, absorbents, etc) should be recovered for appropriate disposal at a permitted landfill facility. Please contact the facility before attempting delivery.
- The recovered substances should be stockpiled upon plastic and covered to prevent oil runoff, until appropriately managed.
- By February 2, 2018, please complete and return the attached <u>Written Contamination</u>
 <u>Incident Follow Up Report</u> form (this is a standard form so some questions will not apply
 to this situation, just skip those questions). Electronic options for completing the form can
 be found at <u>http://denr.sd.gov/des/gw/Spills/Incident_Follow_Up_Report.aspx</u>

 - c. SUMMARY: At 1715 on January 3, 2018 the Ethan Fire Department responded to a 911 call for a fire at 26315 405th Ave. in rural Ethan. The EFD arrived on scene at 1730 and extinguished the fire. At 1937 Davison County Emergency Manager Jeff Bathke received a phone call from Brian Mclure with the Ethan Fire Department, due to a large amount of oil spilled on the ground due to the fire. EM Bathke was en route at 1945 and arrived on scene at 2005. EM Bathke gathered information from Curt Mueller (owner) and the EFD. Approximately 240 gallons of oil were stored in plastic containers, 8' off the ground in the SW corner of the shop; which had melted. The oil saturated approximately 1/3 of the 50'x80' dirt floor of the shop (40'x35'=1,400 SF), an area in front of the west door (20'x40'=800 SF), and an area to the south of the shop (20'x80'=1,600 SF) for a total of 3,800 SF. A straw dike was placed to the south of the shop to slow/stop the oil flow, which worked. Due to the extreme cold, the water froze and contained the contamination.

EM Bathke called Duty Office Brad Maskovich at 2026. Duty Officer Maskovich notified Rick Lancaster from the DENR Ground Water Quality Program Spills Section. EM Bathke also contacted Sherrie Petersen from the Dept. of Agriculture to inform her of the incident. EM Bathke was 10-7 @ 2100, with a planned follow up in the morning.

At 0800 on January 4, 2018, EM Bathke called Rick Lancaster from DENR. As a farmer, Mr. Mueller has exemptions which would allow him to excavate the contaminated soil and treat it himself, or he could have it hauled to the landfill. At 0830 on January 4, 2018, EM Bathke, Deputy EM Jenniges, and Dept. of Ag Agent Petersen returned to the scene to assess the situation. Deputy EM Jenniges confirmed the Mitchell Landfill would accept the contaminated soil, which Mr. Mueller planned to do. The structure and most equipment should be considered a total or significant loss.

The Insurance company is Desmet Insurance. Mr. Mueller was planning to meet with the Agent on the afternoon of January 4th.



The Department of Environment and Natural Resources (DENR) has reviewed the environmental site assessment information provided to this office and assigned this site a case file of 2017.223. Based on the information provided in these reports, it appears that components of petroleum and volatile organic compounds were identified in soil and ground water at the site.

Due to the fact ground water is not being used for human consumption and the level of petroleum impacts in soil were below state risk based action levels, DENR is not requiring further investigation or remediation and is placing 2017.223 into the "No Further Action" category. The No Further Action category will be recorded in DENR's release database and can be found at our internet website (http://arcgis.sd.gov/server/denr/spillsviewer/).

It is believed that historic operations on the site contributed to the identified contamination. Please note that if contaminated soil is encountered during future construction activities or future problems arise as a result of this contamination, Bragg Holding LLC and/or the property owner may be responsible for conducting additional assessment and remediation.



I have results back from the lab. Attached, please find the laboratory analytical results from the soil and groundwater samples collected, as well as a draft table with the groundwater sampling results.

Obviously you will need to review the data and make your own conclusions, but I was happy to hear from the lab that the results look pretty good. The soil samples are all below applicable standards. According to the lab there is one analyte that is above current EPA standards for groundwater - 1,2 dichloroethane (1,2 DCA). Please review the results and let us know what the next steps would be.

EXECUTIVE SUMMARY

Nova was authorized by Larson Family Real Estate, LLLP to conduct a Phase I Environmental Site Assessment (ESA) of the Slumberland located at 812 North Rowley Street, Mitchell, South Dakota ("the Property"). Nova has conducted this ESA in general accordance with the scope and limitations of ASTM Designation E 1527-2013, "Standard Practice for Environmental Site Assessments: Phase I Environmental Site Assessment Process". There are no exceptions to, or deletions from the ASTM E 1527-2013 standard practice and authorized Scope of Services, unless otherwise stated herein.

The Property consists of a rectangular-shaped parcel approximately 2.3-acres in size. The Property is designed and used for commercial/retail purposes. Currently, the Property is developed with one structure, the original portion of which was constructed in 1965. The structure at the Property is one story in height and is occupied by a Slumberland furniture store and an event center. Access to the asphalt-surfaced parking lots on the Property is provided from North Main Street to the east, West 8th Avenue to the south and North Rowley Street to the west. The entire parcel is either paved or covered by the building footprint. Loading docks are located at the northwest and northeast corners of the building. No other structures or significant surface features were noted on the Property at the time of the reconnaissance.

The Property appears to have been undeveloped from prior to 1898 until no later than 1914 when a dwelling, ice warehouse and cement block factory were present. By 1923 it appears that the concrete block factory had been repurposed as a farm implement storage building. By 1931 this structure had been removed and the southern half of the Property left vacant. The dwelling and ice warehouse were still present on the northern portion of the Property. In addition, a commercial garage and storefront were present on the northeast corner of the parcel. Two gasoline underground storage tanks (USTs), likely associated with this apparent auto repair business, are depicted adjacent to the east within the North Main Street right-ofway. In 1946, the dwelling, commercial garage and gasoline USTs were still present. The former ice warehouse had been replaced by new buildings also used as ice warehouses. Uses of the Property from 1946 through 1964 included automobile repair/sales, ice and sand sales, and farm equipment sales. The original portion of the current improvements was constructed in the western portion of the Property in 1965 for use as a grocery store. By 1969 uses of the Property included a cafe', grocery store, hardware store, and motorcycle sales. The café, hardware store and motorcycle sales buildings were demolished, and additions were constructed to the grocery store during the 1970s and 1990s. The grocery store was the sole occupant of the Property during the 1990s and 2000s. The grocery store closed, and Slumberland occupied the Property by 2009. The historic use of the Property as a commercial auto repair garage and automobile sales/service from the 1930s through the early 1960s, as well as the two associated USTs located adjacent to the Property boundary (in the right-ofway) represent a recognized environmental condition.

The Property is located in downtown Mitchell. The Property is bound to the north by West 9th Avenue with two residential buildings (108 and 122 West 9th Avenue) and an office building (901 North Main Street) beyond; to the east by North Main Street with a laundromat/drycleaner, auto parts store, and an automotive repair facility (806-818 North Main Street)

Upon arrival, it was determined to be a possible false alarm; as the hole in the ice appeared to be the inlet to the POET water pump. POET was called and asked to burp the pump, which they did. The four individuals who called 911 confirmed this is what they saw. The drone flew it's first flight at 1459, and completed the last flight at 1516. At 1525 SAR was notified to stand down. All equipment was returned, and all SAR Members were 10-8 by 1600.



SUMMARY: On 4-23-2018 Assistant Fire Chief Morris notified Emergency Management that he received a report of a chemical tote floating in Firesteel Creek/Lake Mitchell, and notified Game, Fish & Parks Agent Andy Petersen. At 1410 on 5-23-18, EM Bathke received a call from Chief Overweg that he received a report of a tote in Firesteel Creek. It was unknown at this time if this was the same tote as previously reported one month prior. Chief Overweg instructed EM to contact the reporting party Jeff Harris (605-656-0022) to get the location of the tote. At 1525 EM Bathke and Deputy EM Jenniges arrived at Jeff Harris' house, and boarded his pontoon. Also on board was Marcus Traxler from the Daily Republic, who was contacted by Mr. Harris.

The tote was found approximately 600' northwest of the Railroad bridge, near the inlet of Firesteel Creek to Lake Mitchell (see attached #1-Map). The 250-gallon tote (see attached #2-Tote and #3-Tote gallons) was found with the lower valve shut but did not have a lid on the top. Upon looking inside, used motor oil, an oil

filter, and water was found in the tote (see attached #4-Inside of Tote). The tote was loaded onto the pontoon, and off loaded at Bill's Beach; which is approximately 1,350' to the east of where the tote was found. The tote was then loaded on a trailer and taken to the County Highway Shop/Emergency

Management building at 1224 W. 5th Ave. (see attached #5-Tote on Trailer). At 1649 Chief Overweg was informed the tote was removed from the water and would be properly disposed of. The Duty Officer was called at 1701. Duty Officer Maskovich returned the call at 1706, gathered the initial information, and notified DENR. At 1735, DENR Environmental Scientist Manager/Ground Water Quality Program Kim McIntosh contacted EM Bathke, to gather the initial information. At 1747 GF&P Agent Andy Petersen contacted EM Bathke to explain why the tote was not removed in April. After discussion, we determined it was in fact the same tote, due to the location and description.

Report from GF&P Agent Petersen: On 4-23-18 @ 12:02pm I received a call from City of Mitchell Dispatch. I was told a Chemical tote was in the lake. The Dispatcher said instead of mobilizing the Hazmat crew if I could go and see if it was leaking any chemical. Officer Geuke and myself took a boat and located the chemical tote. There was not a lid on the tote. The tote was approximately less than half full of rainwater. We did not see or smell any chemical in the tote. We tried to lift the tote out of the water onto the boat but could not because of the weight. At 1:51pm I called the city of Mitchell Dispatch and informed them I found the tote and did not see or smell chemical coming from it. I informed them it was too heavy to remove with the boat and manpower I had at that time. Agent Petersen was informed the tote actually contained oil, an oil filter, and water; and that it was removed from the water to be properly disposed of.

The Placard on the tote was 3082 (see attached #6-Placard). The label on the tote indicated the original contents were 2, 4-D. However, the tote did not appear to contain any 2, 4-D (see attached #7-Label).

HWY Superintendent Weinberg disposed of 15 gallons of used oil, 5 gallons of water and and oil filter in the HWY Shop's normal collection process.

There is no way of knowing how much oil, if any, spilled out of the container into

the water; due to the time the tote has been in the water.

On 5-24-18 EM Bathke, Deputy EM Jenniges, and SR Baker launched the Search and Rescue boat at the West End Boat Ramp. We traveled 3.6 miles by water up Firesteel Creek, inspecting both sides for additional totes. Upon reaching the NW 1/4 of Section 35-104-61, the boat could no longer operate. We then inspected all shoreline of Lake Mitchell. No additional totes or oil slick was found.







II. Responsibilities

Contractor – Build according to plans

- Accurate record keeping and daily construction logs are the contractor's responsibility.
- Contractor shall inspect all materials prior to installation to be sure they comply with construction documents and are clean, free of faults, and in good working order and/or condition.
- Contractor shall be responsible for safety of all personnel and personnel of subcontractors. Engineer and Owner are not responsible for contractor's accidents or injuries.
- Contractor shall have on site a qualified site supervisor at all times when work is being done at the site.
- Contractor and all subs shall contact South Dakota One call prior to digging.
- Contractor will be required to coordinate with other work being done in the area including utility contractors.

- Contractor shall make every effort to minimize erosion and sediment transport. No site generated sediment shall leave the construction site. Weekly inspections of erosion controls are expected and after each rainfall event greater than 0.5 inches. (Work on the damaged bent is expected to occur while the James River is still frozen)

Structure Work

Any substantial changes in project schedule shall be submitted to CDI. Contractor shall provide an updated schedule at each milestone construction meeting.

IV. Site

A. Special considerations

Contractor shall provide on plan sheets or otherwise indicate preferred locations of construction staging, equipment and materials storage, and parking.

Discussion was had on whether Industrial Builders could stage equipment on the northeast landing until traffic control is set up. Davison County said that should be acceptable. Industrial Builders expects to move equipment to beyond the bridge ends once traffic control is set up. Aaron asked if it was acceptable to move the traffic barriers further west to allow for more room for materials and equipment. Chris and

Rusty agreed this would be fine as there are no field approaches near the west end of the bridge.

Special Consideration by Owner include.....

Rusty reminded Industrial Builders that their guardrail subcontractor needs to do a better job of cleaning up debris after installing the guardrail.

Traffic barriers should not be installed until after all other traffic control is set up and the expected time to close the bridge has occurred. Industrial Builders expects to close the bridge to traffic Monday February 19, 2018 at about 9 or 10 AM.

Rusty will put out a press release to notify the public of the upcoming bridge closure.

Davison County Highway Department and Davison County Emergency Management would contact the sheriff's department and Hanson County Emergency Management to inform them of the upcoming bridge closure. The traffic control plan was reviewed to ensure traffic has advance warning and is directed properly onto the traffic control route.

Special Considerations by Engineer include....

A biweekly meeting will be held on-site between Industrial Builders, Civil Design, and Davison County Highway Department.

Due to the early start and the expected cold weather it was emphasized the importance of cold weather concreting requirements as specified by the SDDOT Specifications. Industrial Builders has thermal blankets and heating coils they will use as needed. Aaron pointed out the SDDOT requirement that restricts pouring deck concrete before April unless specified by the Engineer. Chris stated we would discuss that as we get closer and determine if it would be acceptable to pour the concrete deck before April based on the weather.

Brian reminded Industrial Builders that the quantity of deck drains as shown on the plans is incorrect (there are 20 deck drains instead of 28).

Erosion control, specifically silt fence, should be left in place until vegetation is established.

Special Considerations by Industrial Builders include

Aaron asked Rusty if Davison County would have a few trucks they could use to haul away the millings from the bridge. Rusty said they should have trucks available to haul millings.



Reports indicate: approximately 240 gallons of new motor oil was released during the fire event; the released product was confined to the immediate area of the equipment shed; the visibly impacted soils and gravel were excavated; and the excavated material was transported to the Mitchell landfill for disposal.

The Department of Environment and Natural Resources has reviewed information provided to the department regarding the noted spill of mash that resulted from an overflow during a rinse process. It is our understanding that POET promptly initiated actions to contain the spilled substances to frozen surfaces in the immediate area of the overflow. Reports also indicate the substances were recovered and disposed at the Mitchell Landfill.

The department believes the actions taken effectively mitigated the threat to water resources by recovering and appropriately managing the spilled mash. As a result, the DENR Ground Water Quality Program does not intend to require additional actions in response to this event. Case #2018.031 will be placed into the "Closure" category but POET could be required to perform additional assessment and cleanup if problems occur as a result of spills at the site. The Department of Environment and Natural Resources (DENR) has conducted a review of the information that has been provided concerning this case. Based upon that information the DENR Ground Water Quality Program has determined that its case file for #2018.048 can be closed.

According to the information provided to date: approximately 500 gallons of process water was released on March 29, 2018, due to a ruptured line. The process water was spilled on the cement and in the nearby ditch; the solids were scooped up; the water was pumped up from the ditch; and all of the contaminated materials were placed back into the process. The DENR Ground Water Quality Program does not intend to require additional assessment or cleanup actions in response to this event.

The reported activities initiated in response to this event are consistent with the expectations of our program. Please be aware that if environmental problems arise additional assessment and remediation might be necessary. Should you have any questions concerning this letter please contact Kelsey Newling of my staff at 605.773.3296. Thank you for protecting South Dakota's water resources.

Are You Prepared for a Disaster?

isasters can strike quickly and without warning. You could be anywhere - at work, at school, or in a car. What would you do if basic services - water, gas, electricity or telephones were cut off? Families can cope with disasters by preparing in advance and working together as a team. Knowing what to do is your best defense against the burden of a disaster. Being prepared and understanding what to do can reduce fear,

anxiety, and losses that accompany disasters. You should know how to respond to severe weather or any disaster that could occur in your area. Each disaster has lasting effects - people are seriously injured, some are killed, and property damage runs into the billions of dollars.



<u>Watch</u> - A National Weather Service (NWS) product indicating that conditions are favorable for the development of a particular severe weather event. A watch is normally issued for several hours and indicates a need for planning, preparation and an increased awareness of changing weather conditions.

<u>Warning</u> - A product issued by NWS local offices indicating that a particular weather hazard is either imminent or occurring. A warning indicates the need to take action to protect life.

Emergency Supply Kit

Emergency supply kits should be individually tailored to meet the basic survival needs of your family for three days to a week. Most families prefer to store their emergency supplies in one location that is relatively safe, yet easily accessible if evacuation is required. Items may be stored in a 32-gallon trash can, suitcase, duffle bag, footlocker or individual pack.

Emergency Needs

- Battery powered radio
- Water (1 gallon per person/per day)
- First aid kit and manual
- Sleeping bags and blankets
- Utility knife
- Emergency candles
- Manual can opener
- "Special needs" items for family members (infant formula, eye glasses, medications, etc.)
- Waterproof/windproof matches
- Non-perishable foods*
- Flashlight
- Extra clothing
- Whistle

Sanitation Kit

- Plastic bucket with tightly fitted lid
- Plastic trash bags and ties
- Disinfectant
- Improvised toilet seat
- Paper cups and plates
- Plastic utensils
- Personal toiletries
- Baby supplies
- Toilet paper
- Aluminum foil
- Paper towels
- Personal hygienic needs
- Soap



Other Emergency Needs

- Pen and paper
- Money
- Work gloves
- Basic tools
- Toys, books, puzzles, games
- Extra house keys and car keys
- List of contact names and phone numbers
- Hardwired phone (not cordless)

Copies of All Legal Papers

- Marriage license
- House mortgage

*Suggested non-perishable food items: ready-to-eat goods in unbreakable containers, canned meats, juice, fruits & vegetables, powdered milk, infant care foods, crackers, peanut butter, freeze -dried, and dehydrated goods.

Floods

Before a Flood

- Avoid building in a floodplain unless you elevate and reinforce your home. (Local floodplain permit needed)
- Elevate the furnace, water heater, and electric panel if susceptible to flooding.
- Install "check valves" in sewer traps to prevent flood water from backing up into the drains of your home.
- Construct barriers (levees, beams, floodwalls) to stop floodwater from entering the building.
- Seal walls in basements with waterproofing compounds to avoid seepage.
- Have drain plugs available for basement shower drains and toilets.

During a flood

- Listen to the radio or television for information
- Be aware that flash floods can occur. If there is any possibility of a flash flood, move immediately to higher ground. Do not wait for instructions to move.
- Be aware of streams, drainage channels, canyons, and other areas known to flood suddenly. Flash floods can occur in these areas with or without such typical warnings as rain clouds or heavy rain.

If you must prepare to evacuate, you should do the following:

- Secure your home. If you have time, bring in outdoor furniture. Move essential items to an upper floor.
- Turn off utilities at the main switches or valves if instructed to do so by emergency officials. Disconnect electrical appliances. Do not touch electrical equipment if you are wet or standing in water.

If you have to leave your home, remember these evacuations tips:

- Do not walk through moving water. If you have to walk in water, walk where the water is not moving. Use a stick to check the firmness of the ground in front of you.
- Do not drive into flooded areas. If floodwaters rise around your car, abandon the car and move to higher ground if you can do so safely. You and the vehicle can be quickly washed away.

After a Flood

- Listen for news reports to learn whether the community's water supply is safe to drink.
- Avoid floodwaters; water may be contaminated by oil, gasoline, or raw sewage. Water may also be electrically charged from underground or downed power lines.
- Avoid moving water.
- Be aware of areas where floodwaters have receded.
 Roads may have weakened and could collapse under the weight of a car.
- Stay away from downed power lines, and report them to the power company.
- Return home only when authorities indicate it's safe.
- Clean and disinfect everything that became wet. Mud left from floodwater can contain sewage and chemicals.
- Call a professional to do a proper cleaning and drying of your home to prevent harmful mold growth.

Thunderstorms/Lightning

Before Thunderstorms

- Remove dead or rotting trees and branches that could fall and cause injury or damage.
- Remember the 30/30 lightning safety rule: Go indoors if after seeing lightning you cannot count to 30 seconds before hearing thunder. Stay indoors for 30 minutes after hearing the last clap of thunder.

During a Thunderstorm

- If you are in a forest, seek shelter in a low area under a thick growth of small trees.
- If you are in an open area, go to a low place such as a ravine or valley. Be alert for flash floods.
- If you are in open water, get to land and find shelter immediately.
- If you are anywhere you feel your hair stand on its end (which indicates lightning is about to strike), squat low to the ground on the balls of your feet. Place your hands over your ears and your head between your knees. Make yourself the smallest target possible and minimize your contact.

Tornadoes

• Outdoors: Seek shelter in a sturdy building. If none are nearby, lie flat face-down on low ground. Try to be as far away from trees and cars as possible, protecting the back of your head with your arms.



- Mobile Home: Get out! Most tornadoes can destroy even tied-down mobile homes. You should try to find an underground shelter or permanent sturdy building.
- Permanent Building: Avoid windows and being beneath areas under heavy objects like pianos and refrigerators. Try to get in a basement or under sturdy protection like a table or bench.

Tornado Myth vs. Fact

Mvth: The low pressure with "explode" as the tornado passes overhead

Fact: Violent winds and debris slamming into buildings cause most structural damage

Mvth: Windows should a tornado causes buildings to opened before a tornado approaches to equalize pressure and minimize damage.

> **Fact:** Opening windows allows damaging winds to enter the structure. Leave the windows alone; instead, immediately go to a safe area.

Extreme Heat

People suffer heat-related illness when their bodies are unable to compensate and properly cool themselves.



The body normally cools by sweating, but under some conditions, sweating isn't enough. In such cases, a person's body temperature rises rapidly. Very high body temperatures may damage the brain or other vital organs. Several factors affect the body's ability to cool itself during extremely hot weather. When the humidity is high, sweat will not evaporate as quickly, preventing the body from releasing heat quickly.

- Drink plenty of fluids.
- Replace salt and minerals: sweating removes salt and minerals from the body.
- Wear appropriate clothing and sunscreen. Choose lightweight, light-colored, loose fitting clothing.
- Pace yourself and don't over-exert.
- Stay cool indoors.
- Do not leave children or pets in vehicles.

Wildfires

Wildfires often begin unnoticed. They spread quickly, igniting brush, trees, and homes. Reduce your risk by preparing now - before a wildfire strikes. Meet with your family to decide what to do and where to go if wildfires threaten your area. People unintentionally start most wildfires....find out how you can promote and practice wildfire safety.

- Contact your local fire department or forestry office for information on fire laws.
- Make sure that fire vehicles can get to your home. Clearly mark all driveway entrances and display your name and address.
- Report hazardous conditions that could cause a wildfire.
- Post fire emergency telephone numbers.
- Plan several escape routes away from your home both by car and by foot.
- Talk to your neighbors about wildfire safety. Plan how the neighborhood could work together after a wildfire.

- Consider how you could help those with special needs such as an elderly or disabled neighbor.
- Make plans to take care of children who may be on their own if parents can't get home.
- If you are warned that a wildfire is threatening your area, listen to your battery-operated radio for reports and evacuation information. Follow the instructions of local officials.
- Confine pets to one room. Make plans to care for your pets in case you must evacuate.
- Arrange temporary housing with a friend or relative.



Animals in Disasters

Disasters disrupt and affect everything in its path, including pets, livestock, and wildlife.

Pets in Disaster

Pets need to be included in your household disaster plan since they depend on you for their safety and well being. It's important to consider and prepare for your pets before disaster strikes. Consider the following:

- If you must evacuate, do not leave pets behind there is a chance they may not survive or get lost before you return.
- With the exception of service animals, pets are not typically permitted in emergency shelters.
- Find out before a disaster which local hotels and motels allow pets and where pet boarding facilities are located. Be sure to include some outside your local area.
- Only some animal shelters will provide care for pets during emergency and disaster situations.
- Be sure you have a secure pet carrier or leash for your pet - they may need to be restrained during tense emergency situations.
- Assemble a disaster kit for your pet which includes food, water, medications, veterinary records, litter box, food dishes, and other supplies that may not be available at a later time, and an information sheet with pet's name, medical history, and behavior problems.
- All animals should have some form of identification.



Motorist Safety Tips

Disaster driving is one part preparedness, one part common sense, and one part learning from experience - your own, and others. After almost every disaster, search and rescue teams find victims who might have survived if they had known whether to stay or abandon their cars. The following are safety tips for drivers in different emergencies. This information can easily be kept in the glove compartment of your car. In any situation, the most important rule to follow is to not panic.

Flood: Get out of the Car

Never attempt to drive through water on a road. Water can be deeper than it appears and water levels can rise very quickly. Most cars will float dangerously for at least a short while. A car can be buoyed by floodwaters and then swept downstream during a flood. Floodwaters also can erode roadways, and a missing section of road - even a missing bridge - will not be visible with water running over the area. Wade through floodwaters only if the water is not flowing rapidly and only in water no higher than the knees. If a car stalls in floodwater, get out quickly and move to higher ground. The floodwaters may still be rising, and the car could be swept away at any moment.

Tornado: Get out of the Car


A car is the least safe place to be during a tornado. When a warning is issued, do not try to leave the area by car. If you are in a car, leave it and find shelter in a building. If a tornado approaches and there are no safe structures nearby, lie flat in a ditch or other ground depression with your arms over your head.

Summer Heat: Get out of a Parked Car

During hot weather, heat build-up in a closed or nearly closed car can occur quickly and intensely. Children and pets can die from heat stroke in a matter of minutes when left in a closed car. Never leave a person or animal in a parked car during periods of high summer heat.



According to the information provided to date: approximately 300 gallons of process water was released, due to a loose seal. The corn mash was spilled on the gravel at the facility; the contaminated materials were cleaned up; and all of the contaminated materials were placed back into the process. 

This office has recorded the information provided about this event on an initial spill report form (enclosed for your review). The procedures for assessment and remediation of a release such as this were developed to prevent pollution of the waters of the State. In this situation, the following steps must be taken:

- Excavate the contaminated materials. All contaminated materials must be characterized and properly disposed.
- Obtain representative soil samples to ensure adequate cleanup. The samples should be analyzed for PCBs and petroleum. Once sample results are available and provided to DENR, we will determine if further cleanup is necessary.
- Please provide a written narrative detailing the actions taken in response to this
 event, to include the final disposition of recovered material, disposal receipts, and
 post cleanup pictures.

The Department of Environment and Natural Resources will be placing this file into "No Further" Action" status based on the following:

Kim Mallor

- Case file 2018.083 was initiated on May 23, 2018 in response to a report of a floating tote that was recovered from Firesteel Creek during the afternoon of May 23, 2018. Records indicate: Davison County Emergency Manager Jeff Bathke initiated actions to recover the tote from Firesteel Creek; the tote contained approximately 15 gallons of used engine oil and an oil filter; the tote and its contents was transported to the Davison County Highway Shop; and the contents were managed in accordance to Davison County Highway Department standard operating practices.
- It is understood: the tote may have been located in Firesteel Creek for a month or more; the tote did not appear to have sunk below the water's surface in its entirety but the lid was missing; and no visual evidence of oil spillage into Firesteel Creek was noted.
- The person most responsible for the tote and its contents is unknown. The tote had been previously used to store 2,4D Ester but had apparently been emptied and was being used to store used engine oil. It is unknown when, how, or from where the tote was displaced.
- It is believed the actions taken by Davison County Emergency Manager Jeff Bathke and those assisting his efforts effectively mitigated the threats to Firesteel Creek from the floating tote of used engine oil. The department appreciates the efforts of Davison County to protect water resources.
- It is understood a spillage of engine oil was not identified. The negative consequences, if a spill occurred from the container, have already been realized.

The department will place 2018.083 into "No Further Action" (NFA) status. The placement of case 2018.083 into NFA status by the Ground Water Quality Program in no way limits the investigation or actions that might be required by other regulatory authorities. Case 2018.083 can be reopened if information is provided that negates the statements listed above.

The Department of Environment and Natural Resources (DENR) has conducted a review of the information that has been provided concerning this case. Based upon that information the DENR Ground Water Quality Program has determined that its case file for #2018.070 can be closed.

According to the information provided to date: approximately 22 gallons of transformer oil containing PCB was released, due to a storm event. The transformer oil was spilled on the gravel; the gravel was excavated and backfilled; and the contaminated materials were taken to the Mitchell Landfill. The DENR Ground Water Quality Program does not intend to require additional assessment or cleanup actions in response to this event.

The reported activities initiated in response to this event are consistent with the expectations of our program. The Department of Environment and Natural Resources' Ground Water Quality Program has conducted a review of the information provided concerning a distillate overflow event and has determined DENR case file #2018.135 can be closed.

Reports indicate: approximately 50 gallons of distillate (condensed steam w/corn fats) was released as the result of an overflow; the overflowed product was confined to the immediate area; the confined distillate was recovered; and the recovered substance was returned to the system process. It is understood the overflow threatened neither water sources nor drainages.

The department will be closing case 2018.135 based upon the reported actions. 



Staff from the South Dakota Department of Environment and Natural Resources (DENR) have reviewed the tank removal information provided for the above referenced property. Based upon the information provided, it appears that the contamination identified during the tank removal is associated with previously identified contamination. Therefore, the department will not initiate a new case file, will include the tank removal report in the department's 2002.237 file, and will not require further assessment or cleanup.

It should be noted that soil contamination above department action levels exists on site; therefore the site will continue to be assigned a No Further Action designation. If future construction activities result in contaminated soil being removed, it must be properly disposed at a permitted facility. In addition if future exposure pathways are created, or if problems arise from remaining contamination associated with this release, Casey's General Stores will be responsible for doing any additional assessment or cleanup activities. Casey's General Stores may also be responsible for further assessment and cleanup actions if there is a change in the use of this property or adjacent affected properties that increases the risk to human health and the environment from contamination associated with this release.

The Department of Environment and Natural Resources' Ground Water Quality Program has conducted a review of the information provided concerning a a discharge of mash and has determined DENR case file #2018.190 can be closed.

Reports indicate: approximately 50 gallons of mash (water/corn flour) was released as the result of displaced air pocket; the 'burped' mash was confined to the immediate area; the confined mash was recovered; and the recovered mash was placed into a designated waste-storage-dumpster for disposal at the Mitchell Sanitary Landfill. It is understood the discharged mash threatened neither water sources nor drainages.

The department will be closing case 2018.190 based upon the reported actions. The closure status will be recorded in DENR's release database and can be found at our internet website http://arcgis.sd.gov/server/denr/spillsviewer/. Please be advised, though case 2018.190 will be closed, POET Biorefining Mitchell LLC could be required to direct further assessment and cleanup if problems arise at the site.
