# CALL TO ORDER

#### **APPROVE MINUTES**

Motion by Claggett, second by Weitala to approve the minutes from the January 19, 2021 meeting. All members present voted aye. Motion carried.

#### **PUBLIC INPUT**

Jerry Opbroek from the Stump Shooters Archer Club appeared before the Board to request the use of an additional space at no charge during their event at the Davison County Fairgrounds on February 19 through 21<sup>st</sup>. Chairperson Bode stated that no action will be taken today but the board would consider the request as an agenda item at a future meeting.

#### SIGN SHORT FORM AGREEMENT

The Bid letting on January 19, 2021 resulted in a low bid of \$570,864.4 submitted by Prahm Construction Inc. and as recommended by Civil Design Inc. and concurred with by the SD DOT. #### **VSO ANNUAL REPORT**

Veteran's Service Officer Craig Bennett presented to the Board his annual report for the VSO. Bennett reported on the training of the new VSO Administrative Assistant Krause. Bennett stated that Krause is doing everything that he expected out of the get go, however Bennett does not expect training to be linear but more allencompassing. Bennett stated the number of interview contacts was down in 2020, 697 from 918 in 2019 as would be expected. Compensation claims were also down from 2019, with 164 claims in 2020 and 230 in 2019. Bennett stated that although the interviews and claims were down in 2020 the dollar amount of claims paid was equivalent to 2019 at 3.3 million. Bennett also reported on the DAV program, he stated in 2020 there were 230 rides given, 641 volunteer hours worked, and currently has 20 drivers.

Bennett also shared his experience with a recent suicide of a local veteran, and although it was not his first experience with veteran suicides, this was his first in Mitchell. Bennett wanted to convey the multitude of resources available for not only veterans but the community in general that are dealing with depression or suicidal ideations, including the Veteran Crisis Line 1-800-273-8255, or for the public and veterans 211. Also, these resources are available to those around someone that may be struggling that may be hesitant to reach out for help themselves.
