CALL TO ORDER

Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairperson Bode.

APPROVE MINUTES

Motion by Claggett, second by Kiner to approve the minutes of the April 13, 2021 meeting. All members voted aye. Motion carried.

PHONE SYSTEM INFORMATION

Jordan Thuringer, Tech Solutions, who manages the counties IT services and Randy Northrup, Santel Communications, appeared before the Board to present information regarding the counties telephone system and talk about why it should be upgraded.

Mr. Thuringer talked about the aging system and why he felt the County needed to upgrade.

Mr. Northrup presented a quote from Santel Communications after a committee had vetted two quotes.

The commissioners took no action on the upgrade.

SIGN VANGUARD CONTRACT

Motion by Weitala, second by Claggett to authorize chairperson to sign the contract with Vanguard with licensing fees totaling \$13,725.00 and parcel conversion of \$27,200. All members voted aye. Motion carried.

MITCHELL AREA CHAMBER OF COMMERCE QUARTERLY REPORT

David Lambert, Acting Chamber/Development Corp. Director, presented the 1st quarterly report for 2021. One of the highlights noted was that workforce/housing are the #1 and #2 issues both locally and regionally.

Lambert reported the Mitchell Area Development Corp. had offered use of one of their properties for the Community Covid Clinic.

The Convention & Visitors Bureau is gearing up for tourist season with a new 2021 Mitchell Guide to Everything. The guide has been shipped to all 50 states and 10 countries.

The Chamber hosted the 2nd annual 'Restaurant Rumble' in January, with 12 restaurants participating. They have hosted other events as well this quarter.

APPOINT PHYSICAL PLANT MANAGER

Motion by Reider, second by Kiner to appoint Joel Rang as the new Physical Plant Manager effective June 12, 2021 with a wage of \$57,633.10, with a six-month introductory wage increase. All members voted aye. Motion carried.

APPROVE NEW HIRE

At the request of ROD Young, motion by Claggett, second by Reider to approve the hire of Bridgett Nelson, who currently works in a ROD office, as ROD deputy II, at a rate of \$18.04, effective May 17, 2021. All members voted aye. Motion carried.

REMOVE SPRING WEIGHT LIMITS

At the request of Highway Superintendent Weinberg, motion by Kiner, second by Claggett to remove Spring Weight Limits effective April 29, 2021. All members voted aye. Motion carried.

SIGN STRIPING AGREEMENT

Motion by Claggett, second by Reider to authorize chairperson to sign the 2021 Striping Project agreement with SDDOT with the County responsible for \$47,547.46. All members voted aye. Motion carried.

SDDOT USE OF COUNTY PUMPS

It was noted that SDDOT has requested the use of the County's diesel pumps for approximately 4-6 weeks while theirs are under construction. County personnel and SDDOT personnel will work out details such as hours of use, billing, etc...

AUTHORIZE RENTAL OF TRACTOR

At the request of Highway Superintendent Weinberg, motion by Claggett, second by Reider to authorize the rental of a John Deere tractor from C&B Operations at a rate of \$25 per hour with a maximum 200 hours to reclaim gravel on roads, as the tractor owned by the County is awaiting parts. All members voted aye. Motion carried.

DITCH COMPLAINT

Shane Mulloy and Art Schlenker appeared before the Board to voice their concerns with the ditch located at 39482 262nd St. Mr. Mulloy said there had been equipment in the area and then it was pulled off. He was frustrated the ditch wasn't cleaned when the equipment was in the area.

Chairperson Bode explained an excavator couldn't come out until weight limits were lifted, which will be happening on Thursday. She said they had started to clear the ditch but something had happened to the equipment so they had to stop.

APPROVE INTRODUCTORY WAGE INCREASE

At the request of Corrections Administrator Radel, motion by Reider, second by Weitala to approve an introductory wage increase of \$.50 for Shawn Jerke, effective May 1, 2021. All members voted aye. Motion carried.

CORRECT STARTING WAGES

At the request of Corrections Administrator Radel, motion by Claggett, second by Weitala to correct starting wages for Sergeants Michael Salathe and Marco Mora to \$19.64 retro-active to March 20, 2021. All members voted aye. Motion carried.

Motion by Kiner, second by Reider to appoint Steve Harr as acting Sheriff, until such time as a permanent replacement has been appointed, at a rate to be determined, effective May 1, 2021.
