Chairperson Bode called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. Members of the Board present were Claggett, Kiner, Weitala, Bode. Absent Reider. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairperson Bode.

APPROVE MINUTES

Motion by Claggett, second by Kiner to approve the minutes of the November 16, 2021, meeting. All members present voted aye. Motion carried.

OPEN SUPPLEMENTAL BUDGET HEARING

At 9:15 a.m., motion by Kiner, second by Claggett to open the Supplemental Budget Hearing for the Courthouse Building and Highway departments. All members present voted aye. Motion carried.

ADOPT RESOLUTION TO SUPPLEMENT COURTHOUSE BUILDING AND TRANSFERS IN AND OUT FOR HIGHWAY BUDGETS

Motion by Kiner, second by Claggett to adopt the following resolution to supplement the Courthouse Building Budget, and transfer cash from General Fund into Highway Fund, and supplement the Highway budget. A roll call vote was taken as follows. Claggett – aye, Kiner – aye, Weitala – aye, Bode – aye Reider – absent. Motion carried.

Resolution #113021-01 Supplement County Courthouse, Transfer Out of General Fund And into Highway Fund Budgets

Whereas, the Courthouse Building, General Fund Transfer Out and Transfer into Highway budgets are not sufficiently funded by the adopted 2021 annual budget to pay expenses for the remainder of the year 2021; and

Whereas, SDCL 7-21-22 states that in the event of the passage and enactment of any law during a fiscal year and after the adoption of the annual budget for a following fiscal year, imposing some new obligation or duty upon a county, or in the event of the failure to provide by the final budget a sufficient revenue to enable the county to conduct the indispensable functions of government in any department, or to pay just obligations upon the county for the necessary conduct of the courts, or for the necessary aid and support of the poor or to discharge any duty which it is the lawful duty of the county to discharge, and of which requires the incurring of liabilities or expenditures of funds for a purpose or object for which no provision has been made in the annual budget for such fiscal year, and when such occasion arises the board must make, approve, and adopt a supplemental budget providing therein for an appropriation for such purposes in such amount as the board may deem necessary, and such budget shall set out in detail each item for which an appropriation is made and the amount to be appropriated for each item, with the time and place when the same will be considered and adopted

by the governing board, shall be given in such manner as the board may determine, provided that the time fixed for considering and adopting the same shall not be less than ten days from date when such notice is first given; and

Whereas, there was not sufficient appropriation included in the 2021 budget to pay all Courthouse Building, General Fund Transfer out and Transfer into Highway Department expenses.

Now, therefore be it resolved, that \$185,455 from the General Fund Cash line item 10100A1010000 be supplemented to the Courthouse Building Department budget various line items, and to transfer \$1,228,949 from the General Fund Cash line item 10100A1010000 into the Highway Fund Cash line item 20100A1010000 and supplement the various line items in the amount of \$1,228,949.
