

DRAINAGE BOARD
September 21, 2021

CALL TO ORDER

Chairman called the regular meeting of the Davison County Drainage Board to order at 7:00 p.m. Auditor Kiepke took roll call as follows: Members of the Board present were Jay Larson, Jerry Buchholz, Mark Klumb, Commissioner Kiner. Ex-Officio members present were Director Bathke and Auditor Kiepke. Absent Chet Edinger, Gregg Bult, Commissioner Bode, Highway Superintendent Weinberg.

MEETING EXPECTATIONS

Chairman Larson recited expectations of the meeting.

A checklist of items required in accordance with the Davison County Drainage Ordinance and SDCL 46A-10A will be considered on each permit. The checklist is on file in the Davison County Auditor's office and Drainage Administrator's office.

APPROVE AMENDED AGENDA

Motion by Klumb, second by Kiner to approve the agenda for the September 21, 2021, meeting. All members present voted aye. Motion carried.

APPROVE MINUTES

Motion by Buchholz, second by Klumb to approve the minutes of the July 20, 2021, meeting. All members present voted aye. Motion carried.

PUBLIC INPUT

Chairman Larson asked for any public input public input for items not on the agenda and reminded the public that no action will be taken. Hearing none, the meeting moved forward.

CONSIDER ESTABROOK DRAINAGE REQUEST

Motion by Klumb, second by Buchholz to grant a drainage permit to drain to the NE ¼ of Section 5, T 104 N, R62W of the 5th P.M., Davison County, SD as requested by Scott Estabrook of Estabrook Ag, LLC., pursuant to Section 2 and 3 of the Davison County Drainage Ordinance as adopted on 8/27/2013.

The water currently runs to the same location as the proposed drainage system, which will outlet into an un-named stream, which will drain into a blue line. The blue line will drain into Firesteel Creek in the SW ¼ of Section 28-104-61, which drains to Lake Mitchell, over the spillway and again into Firesteel Creek, the James River, then the Missouri river.

REVIEW ADMINISTRATIVELY APPROVED DRAINAGE PROJECTS

Davison County Drainage Administrator Bathke presented the following Administratively approved projects to the Board. Specific information on each project can be found on file in the Drainage Office, Davison County, SD.

Duane Kummer (by Davison County) – Removal of silt in field and tree overgrowth to the south and southwest of the farm.

MISCELLANEOUS ITEMS

Administrator Bathke gave an update to a current drainage project.

The Miiller/Bechen/Thue Drainage Project is almost complete. The Highway Department shaped the ditch from the outlet of the 12” drainpipe on H&R property from the south pond all the way to Kibbee Ditch. Due to poor elevation, no drainage work was completed on the far north end of Merle Bechen’s property.

Items yet to be completed are seeding the entire project (NRCS), install the concrete crossing on Müller’s land (once crops are harvested), and install the concrete crossing on Bechen’s land (Rusty will install once he orders more product), and installation of an approach on the SE corner of Bechen’s property.


SET DATE AND TIME FOR NEXT MEETING

Chairman Larson set October 12, 2021, at 7:00 p.m. as the next meeting date and time.


ADJOURN
