PLEDGE

Chairperson Bode opened the meeting with the Pledge of Allegiance.

APPROVE AGENDA

Motion by Claggett, second by Blaalid to approve the December 27, 2022, meeting agenda as amended. All members voted aye. Motion carried.

APPROVE MINUTES

Motion by Claggett, second by Blaalid to approve the minutes from the December 13, 2022, meeting, as amended. All members voted aye. Motion carried.

SIGN SANBORN COUNTY MOU

Motion by Claggett, second by Reider to sign a Memorandum of Understanding between Davison and Sanborn Counties, that provides for Davison County to have a Veterans' Service Officer present in Sanborn County once a month, at a cost of \$7,500 per year. All members voted aye. Motion carried.

SET OUT OF COUNTY JAIL BOARD RATES

Motion by Bode, second by Blaalid to set out of county jail board rates at \$100 per day for the year 2023 and to authorize the Sheriff Harr to send a letter of intent to fully review rates before they are set for 2024. All members voted aye. Motion carried.

SET WORK RELEASE FEE

Motion by Claggett, second by Blaalid to set work release fees at \$20 per day for 2023 and those years thereafter, until such time as the rate is changed. All members voted aye. Motion carried.

APPROVE RESOLUTION FOR CONTINGENCY TRANSFERS

Motion by Claggett, second by Reider to approve the following resolution for contingency transfers for the 2022 budget year. A roll call vote was taken as follows. Claggett – aye, Reider – aye, Blaalid – aye, Kiner – aye, Bode – aye. Motion carried.

Resolution #122722-01 Contingency Transfers

Whereas, SDCL 7-21-32.2 states that no expenditures shall be charged to the line item authorized for by SDCL 7-21-6.1, but such appropriated amount may be transferred, by resolution of the board, to any other appropriation in which insufficient amounts were provided or for items for which no appropriation was provided. When transfers are made from the contingency budget to other appropriations, whose revenue is provided by other than general fund revenues, a transfer of fund balances may be made from the county general fund to such other fund in the amount of the budget transfer.
