CALL TO ORDER

Chairperson Reider called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairperson Reider.

APPROVE AGENDA

Motion by Claggett, second by Kiner to approve the agenda for the September 5, 2023, meeting. All members voted aye. Motion carried.

APPROVE MINUTES

Motion by Claggett, second by Nebelsick to approve the minutes of the August 29, 2023, meeting. All members voted aye. Motion carried.

PUBLIC INPUT

Steve Sibson appeared before the Board to discuss conflicting policy opinions between the Federal Government and Planning & Development District III.

He also stated that climate change is a hoax and presented a hand-out to the Board.

He also talked about Co2 pipelines and food supply.

OPEN 2024 PROVISIONAL BUDGET HEARING

At 9:15 a.m., motion by Blaalid, second by Nebelsick to open the 2024 Provisional Budget hearing. All members voted aye. Motion carried.

ADOPT 2024 PROVISIONAL BUDGET

Motion by Blaalid, second by Claggett to adopt the 2024 Provisional Budget. A roll call vote was taken as follows. Blaalid – aye, Claggett – aye, Kiner – aye, Nebelsick – aye, Reider – aye. Motion carried.

CLOSE 2024 PROVISIONAL BUDGET HEARING

At 9:25 a.m., motion by Blaalid, second by Nebelsick to close the 2024 Provisional Budget hearing. All members voted aye. Motion carried.

SIGN AMENDED VANGUARD CONTRACT

As per the request of DOE Weber, motion by Kiner, second by Nebelsick to sign an amended Vanguard contract to include two (2) additional licenses, with an additional cost of \$2,000. All members voted aye. Motion carried.

APPROVE RECLASSIFICATION

As per the request of Sheriff Harr, motion by Blaalid, second by Nebelsick to approve the reclassification of Kohl Oster from full-time corrections officer to full-time civil deputy at a rate of \$23.89, effective September 29, 2023, or earlier, with a \$.50 wage increase after successful completion of a six-month introductory period. All members voted aye. Motion carried.

SET 2024 OUT OF COUNTY JAIL RATES

As per the recommendation of Sheriff Harr, motion by Nebelsick, second Blaalid to set 2024 out of county jail rates at \$105 per day. All members voted aye. Motion carried.

SET CONFINEMENT/WORK RELEASE RATES

As per the recommendation of Sheriff Harr, motion by Nebelsick, second by Blaalid to set the work release and jail confinement rates at \$30 per day beginning January 1, 2024. All members voted aye. Motion carried.

APPROVE EMPLOYEE CHANGES

Motion by Blaalid, second by Nebelsick to approve the reclassification of Brett Costello from a part-time corrections officer to a full-time corrections officer, at a rate of \$21.93, affective September 2, 2023. All members voted aye. Motion carried.

Motion by Blaalid, second by Nebelsick to approve the hire of Chad Holmberg as a highway equipment operator, with a rate of \$20.00, effective October 2, 2023, with a \$.50 wage increase after successful completion of a six-month introductory period.
