CALL TO ORDER

Chairperson Reider called the regular meeting of the Davison County Board of Commissioners to order at 9:00 a.m. All members of the Board were present. Also present was Auditor Kiepke.

PLEDGE

The Pledge of Allegiance was led by Chairperson Reider.

APPROVE AGENDA

Motion by Nebelsick, second by Claggett to approve the agenda for the December 27, 2023, meeting. All members voted aye. Motion carried.

APPROVE MINUTES

Motion by Claggett, second by Nebelsick to approve the minutes of the December 12, 2023, meeting. All members voted aye. Motion carried.

APPROVE AUTOMATIC SUPPLEMENTS

Motion by Nebelsick, second by Kiner to approve an automatic supplement to 10100x4350212 in the amount of \$319.98 received from the State of SD JJDPA Grant for two file cabinets. All members voted aye. Motion carried.

Motion by Claggett, second by Kiner to supplement the Sheriff's budget Overtime line (4111/211) in the amount of \$3,240.23, Social Security line (4120/211) in the amount of \$247.88 and State Retirement line (4130/211) in the amount of \$259.22 received from the State of South Dakota Highway Safety Overtime Enforcement Grant. Motion by Blaalid, second by Claggett to approve the November 2023 Auditor's Account with the Treasurer in the amount of \$12,543,628.18. All members voted aye. Motion carried.

OPEN PUBLIC HEARING FOR $\mathbf{1}^{\text{ST}}$ READING TO AMEND THE ZONING ORDINANCE

At 9:15 a.m., motion by Kiner, second by Claggett to open public hearing for 1st reading to amend the Davison County Ordinance. All members voted aye. Motion carried.

Discussion was held regarding the amendment to the Davison County Zoning Ordinance.

P&Z Administrative Assistant Wegleitner stated that on October 3rd, 2023, the proposed amendment was denied by the Davison County Planning and Zoning Board. On October 23rd it was decided to continue setting the date of the 1st reading until October 31st. The 1st reading was then set for December 27th, 2023.

A letter in support of the change to the ordinance was submitted by Michele Rumbolz & Scott Rumbolz.

Jeremy Jensen, owner of Jensen Capital & Development and Jensen Design Build spoke in favor of the amendment as he is the person wanting to develop the area.

Mitch Peterson of Davenport, Evans law firm appeared on behalf of his client, Peggy Kelley. He cited Section 13-05A1 of the Davison County Zoning Ordinance which in part states that special circumstances must exist which require the land to be rezoned. The special circumstances do not result from the applicant. The change in zoning will not confer on the applicant any special privilege.

He also cited Section 13-05A6 which stated that no petition for amendment or change in zone shall be authorized unless the County Commission finds that the condition, situation, or the intended use of the property concerned is unique, required, or necessary as to make reasonably practicable the amendment or change in zone.

Marsha Schulz stated that she lives across the street from the area Mr. Jensen would like to develop and doesn't feel Mr. Jensen has met the requirements to rezone.

Motion by Nebelsick, second by Blaalid to set the second reading to amend the Davison County Zoning Ordinance on January 16, 2024, at 9:15 a.m. A roll call vote was taken as follows. Nebelsick – aye, Claggett – nay, Blaalid – aye, Kiner – aye, Reider – aye. Motion carried.

ADOPT RESOLUTION TO SUPPLEMENT BUDGETS FOR 2023

Motion by Claggett, second by Kiner to adopt the following resolution to supplement the Care of Poor, Jail, Indigent Defender and Highway budgets. A roll call vote was taken as follows. Claggett – aye, Kiner – aye, Nebelsick – aye, Blaalid – aye, Reider – aye. Motion carried.

Resolution #122723-02 Supplement Care of Poor, Jail, Indigent Defender and Highway Budgets

Whereas, the Care of Poor, Jail, Indigent Defender and Highway budgets are not sufficiently funded by the adopted 2023 Annual budget to pay expenses for the remainder of the year 2023; and

Whereas, SDCL 7-21-22 states that in the event of the passage and enactment for any law during a fiscal year and after the adoption of the annual budget for a following fiscal year, imposing some new obligation or duty upon a county, or in the event of the failure to provide by the final budget a sufficient revenue to enable the county to conduct the indispensable functions of government in any department, or to pay just obligations upon the county for the necessary conduct of the courts, or for the necessary aid and support of the poor or to discharge any duty which it is the lawful duty of the county to discharge, and of which requires the incurring of liabilities or expenditures of funds for a purpose or object for which no provision has been made in the annual budget for such fiscal year, and when such occasion arises the board must make, approve, and adopt a supplemental budget providing therein for an appropriation for such purposes in such amount as the board may deem necessary, and such budget shall set out in detail each item for which an appropriation is made and the amount to be appropriated for each item, with the time and the place when the same will be considered and adopted by the governing board, shall be given in such manner as the board may determine, provided that the time fixed for considering and adopting the same shall not be less than ten days from date when such notice is first given; and

Whereas, there was not sufficient appropriation included in the 2023 budget to pay all Care of Poor, Jail, Indigent Defender and Highway Department expenses.

Now, therefore be it resolved, that \$96,762.00 from the General Fund Cash line item 10100A1010000 be supplemented to the County Coordinator budget, various line items, in the amount of \$2,955.00, the Jail budget, various line items, in the amount of \$53,007.00, the 911 budget, various line items in the amount of \$1,705 and the Urban/Rural Development budget, various line items, in the amount of \$39,095.

Be it further resolved, that \$232,583.00 from the Highway Fund Cash line item 20100A1010000 be supplemented to the Highway budget, various line items.
