**RESOLUTION # 061825-01**

**Resolution of Support**

**WHEREAS**, Davison County, South Dakota, asserts that the primary duties of the emergency management personnel services are to protect life and property, and they receive intensive and specialized training to carry out those duties; and

**WHEREAS**, Davison County, South Dakota, asserts the duties are hazardous to the employee, are physically demanding, and directly subject the employee to a risk of injury or death; and

**WHEREAS**, Davison County, South Dakota, asserts that the capacity to effectively perform the duties declines with advancing age, resulting in increased risk to both the employee and public and justifying an earlier normal retirement age

**WHEREAS**, Davison County, South Dakota, acknowledges that both the employer's and employee's contributions to the South Dakota Retirement will increase by 2%, and family benefits are not payable upon the death of a member who has reached normal retirement age.

**Now, Therefore, be it resolved**, that Davison County, South Dakota, through its Commission, supports the Emergency Management positions being classified as Class B Public Safety. This said resolution was declared duly passed and adopted.
