

**September 16, 2025**

**CALL TO ORDER**

Chairman Reider called the Davison County Board of Commissioners meeting to order at 9:00 A.M. Members of the board present were Claggett, Kiner, Nebelsick, Blaalid and Chairman Reider. Also present was Auditor Wingert.

**PLEDGE**

Commissioner Reider opened the meeting with the Pledge of Allegiance.

**APPROVE AGENDA**

Motion by Claggett; second by Kiner to approve the agenda. All in favor - aye. Motion carried.

**APPROVE MINUTES**

Motion by Claggett; second by Nebelsick to approve the minutes of the September 2, 2025, meeting. All in favor - aye. Motion carried.

**PUBLIC INPUT**

Steve Sibson informed the board that a portion of a roundabout approved by the Mitchell City Council would be on county property.

**INTO BOARD OF ADJUSTMENT**

Motion by Blaalid; second by Nebelsick to move into BOA at 9:15 A.M. All in favor - aye. Motion carried.

**OUT OF BOARD OF ADJUSTMENT**

Motion by Blaalid; second by Nebelsick to move out of BOA and reconvene as Board of Commissioners at 9:26 A.M. All in favor - aye. Motion carried.

**PLATS**

Motion by Nebelsick; second by Blaalid, to approve the plat requested by Carl and Bailey Betts of Lot D1, a subdivision of Lot D in the SW ¼ so Section 23, T 103 N R 61, West of the 5<sup>th</sup> PM., Davison County, South Dakota. All in favor - aye. Motion carried.

**HIGHWAY SUPERINDENDENT WEINBERG**

Highway Superintendent Weinberg brought forth a contract from Timmons Construction in the amount of \$315,100.48 for bridge construction. Location is on 407<sup>th</sup> Avenue between 262<sup>nd</sup> and 263<sup>rd</sup> St. Motion by Nebelsick; second by Blaalid to approve the signing of the contract. All in favor - aye. Motion carried.

Weinberg discussed his five-year plan at length with the board. Motion by Nebelsick; second by Kiner to approve the five-year plan. All in favor - aye. Motion carried.

Bruce Haines talked with Weinberg and the board about a bridge in Prosper Township that is in need of attention due to the railings. Potential options to fix this bridge were discussed.

**4-H UPDATE**

Samantha Anderson presented an update on the Davison County Fairgrounds and 4-H. She stated that the South Dakota State Fair went great, and she was able to learn a lot from the experience. Samantha stated she is currently working on four different projects for the upcoming months and is

looking at expanding her social media presence to advertise 4-H activities.

### **SHERIFF HARR**

A discussion was held on the Highway 37/257 intersection. Commissioners, Sheriff Harr, and DOT Engineer Jay Peppel were present for the open discussion. Discussion was held on how the county can be proactive in the prevention of accidents at the intersection. Suggestions such as a stop light, flashing caution lights, no passing signage, speed limit reduction, message boards, and signs indicating slower traffic were discussed. With a hill being so close to the intersection turn, this makes it harder to implement things such as stop lights because of traffic backing up too far and vehicles traveling at a high speed over the hill and/or vehicles being able to see oncoming traffic when pulling out onto the highway. Traffic will continue to be monitored at this intersection where potentially more options will come to light, and continued discussion on safety measures will be discussed.
