**CALL TO ORDER**

Chairman Reider called the Davison County Board of Commissioners meeting to order at 9:00 A.M. Members of the board present were Claggett, Kiner, Nebelsick, Blaalid and Chairman Reider. Also present was Auditor Wingert.

**PLEDGE**

Commissioner Reider opened the meeting with the Pledge of Allegiance.

**APPROVE AGENDA**

Motion by Claggett; second by Nebelsick to approve the agenda. All in favor. Motion carried.

**APPROVE MINUTES**

Motion by Nebelsick; second by Claggett to approve the minutes of the August 26, 2025, meeting. All in favor. Motion carried.

**PUBLIC INPUT**

There was no public input.

**RAFFLE PERMIT**

Motion by Nebelsick; second by Claggett to approve the raffle permit for the Corn Palace Shrine Club/El Riad Shrine. Ticket sales will be from 9/03/25-10/24/25 with \$35,000 in total value of numerous prizes. All in favor. Motion carried.

**ACKNOWLEDGE VOLUNTEERS**

Motion by Claggett; second by Nebelsick to acknowledge the Davison County volunteers. All in favor. Motion carried.

**INTO SPECIAL EVENT LIQUOR LICENSE HEARING**

Motion by Nebelsick; second by Claggett to go into the special event liquor license hearing at 9:15 A.M. All in favor. Motion carried.

**APPROVE SPECIAL EVENT LICENSE**

Motion by Nebelsick; second by Kiner to approve the special event liquor license for the Corn Palace Shrine Club. The event will be held on 10/24/2025 at the Davison County Fairgrounds, 3200 West Havens, Mitchell, South Dakota. No public input was noted. All in favor - aye. Roll call vote was held as follows: Claggett - aye, Kiner - aye, Nebelsick - aye, Blaalid - aye, and Chairman Reider - aye. Motion carried 5-0.

**OUT OF SPECIAL EVENT LIQUOR LICENSE HEARING**

Motin by Blaalid; second by Claggett to move out of the special event liquor license hearing at 9:18 A.M. All in favor. Motion carried.

**SHERIFF HARR**

Sheriff Harr informed the board that his telephone contract at the jail expires on 1/12/2026. Sheriff Harr discussed the two bids he has received: one from the current provider and the second from NCIC. Motion by Claggett; second by Nebelsick to approve the switch from Reliance Telephone to NCIC. All in favor. Motion carried.

## **INTO PROVISIONAL BUDGET HEARING**

Motion by Nebelsick; second by Kiner to go into the provisional budget hearing at 9:51 A.M. All in favor. Motion carried.

## **ADOPT PROVISIONAL BUDGET**

Motion by Blaalid; second by Claggett, to adopt the provisional budget as is. Roll call vote was held as follows: Claggett - aye, Kiner - aye, Nebelsick - aye, Blaalid - aye, and Chairman Reider - aye. All in favor. Motion carried.

## **ADOPT RESOLUTION TO DESIGNATE CAPITAL ACCUMULATIONS**

Motion by Kiner; second by Nebelsick to adopt a resolution to designate capital accumulation funds for the purpose of highway maintenance. A roll call vote was taken as follows: Claggett - aye, Kiner - aye, Nebelsick - aye, Blaalid - aye, and Chairman Reider - aye. All in favor. Motion carried.

### **Resolution #090225-01 Resolution to Designate Capital Accumulations**

**Whereas**, SDCL 7-21-51 states that a board of county commissioners may, by resolution, authorize the accumulation of funds for a period longer than one year for a capital outlay purpose which is otherwise authorized by law. For the purpose of this section, the term, capital outlay purpose, includes any purpose which is extraordinary in nature, exceeds the funding ability of a single-budget year, and may result in the purchase of services, materials, supplies, or equipment. The resolution is enacted if approved by a vote of sixty percent or more of the governing body and shall clearly set forth the purposes for which the funds are to be accumulated and the maximum amount that may be accumulated. The funds to be accumulated shall be expended within eighty-four months from the date of the resolution. If the specific purpose for which the funds are accumulated is no longer necessary, the funds shall revert to the fund from which the funds were originally appropriated. The amount of accumulation for a specific purpose may not exceed five million dollars. The accumulation of funds pursuant to this chapter is in addition to any accumulation of funds authorized by § 7-21-18.1; and

**Whereas**, Davison County wishes to continue to accumulate funds for the purpose of highway maintenance; and

**Whereas**, the commissioners wish to continue to accumulate \$400,000 for the years 2025 through 2029 for highway maintenance.

**Now, therefore be it resolved** that the existing \$897,880 from 2022 and \$600,000 total from 2023, 2024, and 2025 will be the first installment in capital accumulations designated for the purpose of highway maintenance in the year 2025; and

**Be it further resolved** that an amount of \$400,000 per year for the years 2025 through 2029 be placed in Capital Accumulations. These funds shall be expended within eighty-four months from the date of the resolution. If the specific purpose for which the funds are accumulated is no longer necessary or the funds are not expended within the set time period, the funds shall revert to the fund from which the funds were originally appropriated.
